NO PURCHASE NECESSARY TO ENTER OR WIN

1. How to Enter: To nominate a member of your bookselling staff for the sweepstakes, complete the enclosed nomination form, or submit the nomination online at www.candlewickchirp.com on or before October 15, 2011, and your nominee will be entered in a random drawing to win the prize as set forth below. No purchase is necessary to enter or win. Limit one (1) entry per person. Multiple entries will be disqualified. Sponsor assumes no responsibility for late, lost, damaged, or misdirected entries. Entry must be submitted personally, and may not be submitted through the use of automated computer scripts or other programming techniques.

2. Eligibility: This is a trade promotion sweepstakes. Eligibility is limited to persons at least 18 years of age, who are legal residents of the fifty United States and Washington, D.C. and who are booksellers in the fifty United States and Washington, D.C. The sweepstakes is void where prohibited or restricted by law and is subject to all applicable federal, state and local laws and regulations. 3. Prize:

Prize: The prize will consist of a trip to New Orleans, LA for the duration of the 2012 ABA Winter Institute conference (dates tba) for one person (winner) including transportation to and from New Orleans, LA, and standard conference attendee hotel accommodations at the conference site for the duration of the conference (hotel accommodations include room and tax only and do not include meals, incidentals, tips, telephone calls, or any other personal expenses during trip).

No other expenses are included. The method of transportation to and from New Orleans, LA will be determined by Sponsor in its sole discretion.

The approximate retail value of the Grand Prize is \$2,000.00 (actual value may vary depending upon variable travel costs).
